THIS IS A LEGALLY-BINDING CONTRACT FOR THE OWNERSHIP OF ONE ROTTWEILER _____ FROM THE LITTER WHELPED ___ - ___ - ___ BY SIRE _____ AND DAM _____ NAMED _____. THIS CONTRACT IS MADE BETWEEN THE SELLER, EVE'S GARDEN INC. D/B/A/VON EVMAN ROTTWEILERS, 19300 COUNTY ROAD 33, GROVELAND, FL 34736 PHONE: 813-789-1301 AND BUYER: _____.

It should be noted that this contract defines the responsibilities of the buyer and the seller and that it is written for the sole purpose of protecting the Rottweiler breed and the well-being of the puppy. It is hereby agreed by both parties that the following conditions will be met and that no other warranties or conditions are either expressed or implied: The puppy MUST have the Von Evman name in it and must start with the letter of the Breeders recent litter.

1. This animal is being sold as a Show/Breedable prospect Rottweiler. There are some genetic traits that are indicative to the breed which are acceptable for breeding, for example elbow dysplasia, certain eye traits, etc. Only faults and genetic characteristics that are listed as disqualifying faults of the Rottweiler standard for breeding are covered under this contract and the Florida statute 828.29. If this animal should develop a disqualifying fault according to the International and the American Standard for the Rottweiler, then another Rottweiler may be purchased for the pet price of 1000.00. No refunds or monetary assistance are applicable. This will be done only after said animal has been rendered incapable of reproduction and was never bred. A letter from a Veterinarian attesting to this fact along with verification of the tattoo and/or microchip is required and must be sent to Von Evman Rottweilers.

OR

This animal is being sold as a Pet Quality Rottweiler. It cannot be used for breeding unless, at the age of twenty-four months, it no longer has any disqualifying faults according to International or American standards and the difference in price is paid to Von Evman Rottweilers for a pet to show quality. AKC papers shall be furnished by Von Evman Rottweilers only after said animal has been rendered incapable of reproduction and was never bred. A letter from a Veterinarian attesting to this fact along with verification of the tattoo and/or microchip is required and must be sent to Von Evman Rottweilers or a representative of VER evaluates the dog. A pet quality is being sold because it already has a disqualifying fault therefore does not carry any guarantee, including Florida statute section 828.29 and no refunds are applicable. Only show/breedable quality carry the health & genetic portion guarantee according to this contract but the defect must be written on this contract & health certificate for the new owner to be aware of.

2. Vaccination and Medication Schedule. This schedule is followed up to the age when the puppy is sold and should be continued by the new owner. NEVER use vaccines other than Progard, Galaxy, Nobivac Intervet .

- 1 year old and every year after: Intra-Trac 3 (Kennel Cough), DAPPV + L4, Lyme Disease (if in area where needed)
- Once a month: (Flea & Tick preventative), Heartworm Medication
- Once a year or every 3 years, depending upon your State: Rabies

The medication/shot schedule included in our contract and any additional paperwork was designed with the help of numerous Universities and Immunologists at INTERVET-NOBIVAC Veterinary Medical. This schedule is updated periodically when veterinary medical research warrants it. It has always been and always will be the mission of Von Evman Rottweilers to provide our dogs (children) and their masters (friends) with the best and most up-to-date information.

3. Feeding. Our puppies are fed a mixture of Pro Pac dry dog food with egg, cheese, yogurt or cottage cheese, rice, fresh meat cooked with garlic & olive oil, & "Total Canine" which have all the vitamins, antioxidant & Joint formula needed. When the puppy is almost two years old, adult dry food should be given with the same ingredients. Your Rottweiler should always receive Total-Canine and Kelp daily throughout its life. FlorEssence Tea is needed for older dogs as an antioxidant and Cancer preventative. You can contact us on obtaining these supplements or visit our website, www.vonevmans.com, to order. You should never feed your dog plain, dry dog food. Cooking for your dogs is mandatory.

4. Temperament Development. The temperament in Rottweilers are particularly determined by the genetic traits passed on by the parents and mostly environmental as he/she grows up in your home. What you do, how the puppy adapts and is treated will greatly affect how he/she will act when they are older. We want dogs that are protective in nature yet good around children, family, and friends. Never wrestle, play hard, tease or aggravate your puppy. Soft slow strokes and petting is how you touch your puppy. We feel that temperament and socialization are directly related to each other and we spend a great deal of time socializing our puppies until they go into their new homes. The puppies are held, caressed, and exposed to different situations and sounds both with and without their litter mates. Based on our _____ week observation of your puppy, we feel that this puppy if treated friendly and loving and listen to advice written above, will have the temperament to do the following:

It must be pointed out that Schutzhund, police, obedience, protection, tracking, therapy and service training, etc. are just that - training. No dog can just walk on a field and do these things. They must be trained, and trained correctly. We can sell you a dog with a good potential to do these things, but it is up to you to develop this potential in your dog. We would also like to point out the fact that there are many good but more bad dog trainers in the world, and some use rather insane methods to train dogs. Don't do anything crazy to your dog no matter who tells you to do it! We will be more than happy to help you with training ideas or good people to train with. Please do not wrestle with your dog or chain him up. Soft slow pats & caressing will keep your dog calm & clear minded so when he grows up he will be good natured.

5. This animal shall not be used for breeding purposes until it is at least twenty-four months of age, x-rayed clear of Hip Dysplasia, heart clearance and passed at least a basic obedience class, or temperament test and has no disqualifying faults.
6. Said animal shall carry the Von Evman Kennel name in all advertising or conformation shows and obedience trials. The name on the litter registration MUST BE THE SAME AS ON THIS CONTRACT and cannot be change except by VON EVMAN ROTTWEILERS.
7. Ownership of said animal shall be transferred to the Buyer in return for _____.
8. VON EVMAN ROTTWEILERS warrants that said animal is the progeny of animals x-rayed clear of Hip Dysplasia. If said show/breedable animal develops Hip Dysplasia, as evidenced by an OFA evaluation, by age 24 months then VON EVMAN ROTTWEILERS will do the following: Borderline to Moderate Hip Dysplasia - We will sell you another puppy out of a mutually agreeable Sire and Dam for the pet price. Severe Hip Dysplasia - We will give you another puppy out of a mutually agreeable Sire and Dam for only the shipping charges, cost of the flight kennel and health cert. after said animal has been rendered incapable of reproduction and the Veterinarian attests to the fact that he personally read the tattoo # in the ear or microchip and is written on the letter and sent to VON EVMAN ROTTWEILERS by certified mail. No refunds or monetary assistance are applicable. If male turns out breedable, Von Evman reserves the rights to breed to the male for no stud fee to their females.
9. Buyer certifies that he is not acting as an agent for another individual in the purchase of this animal and that he will not sell this animal or any of its progeny to any agent, pet store, puppy mill, i.e., mass commercial kennel, or guard dog business.
10. Buyer agrees that he will give the first right of refusal to VON EVMAN ROTTWEILERS should buyer decide to give up said animal. Any new owner must also agree to abide by the terms entered into on this contract.
11. Buyer certifies that said animal shall reside at his home located at _____ and buyer agrees to take proper safeguards for the care and safety of said animal including proper shelter, food, water, exercise, socialization, proper training for obedience, and have regular immunizations and examinations by a Veterinarian.
12. The purchase of the dog is a hobby and should not be expected to gain income with this dog, including any refunds.
13. Buyer agrees to send clear pictures of said animal at ages six, twelve, and twenty-four months to VON EVMAN ROTTWEILERS. Buyer agrees to send copies of any titles the dog may receive throughout its life.
14. Said animal shall be registered with the AKC. VON EVMAN ROTTWEILERS cannot be held responsible for delays in processing registration papers by AKC and warrants that said animal is fully registrable with AKC.
15. Binders are required for us to reserve all puppies. Once a binder is made it is a commitment by the buyer to purchase said puppy and is therefore non-refundable. This binder pays for all the expenses that occur by VER in the preparation of the purchase of the puppy.
16. VON EVMAN is to be notified before anything medical is to be done to the dog to make sure the diagnosis is correct, unless an emergency occurs and must be taken care of immediately.
17. No other contract or law is implied other than what is stated in this contract.
18. Buyer hereby releases from responsibility VON EVMAN ROTTWEILERS or its officers Evie Lynn from any and all liabilities and or damages by fault of said Rottweiler after said Rottweiler is in the care or possession of Buyer. These damages and liabilities include but are not limited to destruction of property and physical damage to any person or group of people. The seller does not offer and the buyer(s) waives the rights and relief provided by Florida statute 828.29 or any other statutory provision of similar intent in any State by agreeing to the provisions of this contract.

THE ABOVE AGREEMENT IS MADE AND SIGNED THIS _____ DAY OF _____ 20____ BY EVE'S GARDEN INC. D/B/A/VON EVMAN ROTTWEILERS AND THE BUYER TO ASSURE THE WELL-BEING OF SAID ANIMAL AND ITS PROGENY. SHOULD IT BECOME NECESSARY TO ENFORCE ANY PART OF THIS CONTRACT BY LEGAL MEANS. ANY & ALL ATTORNEY'S FEES, COURT COSTS, AND TRAVEL EXPENSES WILL BE THE RESPONSIBILITY OF THE BUYER. THIS CONTRACT SHALL BE DEEMED A LEGALLY-BINDING CONTRACT AND IS UNDER THE JURISDICTION OF THE STATE OF FLORIDA IN THE COUNTY OF LAKE. IT IS FURTHER AGREED THAT THE PLACE OF VENUE SHALL BE LAKE COUNTY, FLORIDA.
